# **Budget 2009** *Canada's Economic Action Plan*

### Ottawa

Over the past several months economies around the world have experienced a very significant downturn. While Canada's economic fundamentals are strong relative to the rest of the world, as a trading nation we are feeling the effects of this downturn.

In response to what most commentators are now referring to as a global crisis, world leaders have agreed to implement coordinated economic stimulus packages equivalent to roughly 2% of each country's GDP.

Budget 2009 - *Canada's Economic Action Plan* meets that global commitment, and provides a comprehensive plan to stimulate our economy, restore confidence, help Canadian families weather the current global storm and invest in the foundations of long-term economic growth.

This plan will enable Canada to emerge from this downturn with a greener and more modern infrastructure, a more skilled labour force, lower taxes and a more competitive economy.

# Mike Takes On Important Role Parliamentary Secretary for Industry Minister

### Ottawa

On November 7, 2008, Mike was sworn in as Parliamentary Secretary to the Minister of Industry, Tony Clement.

The Parliamentary Secretary role is an important one, charged with assisting Minister Clement with his duties. Mike's responsibilities include: answering questions in Question Period, attending public events across the country, and steering legislation through the parliamentary process.

Mike is one of only four incumbent Conservative MPs to have been promoted by the Prime Minister to serve as a Parliamentary Secretary after the October election.

"When Parliament resumes, our government will act decisively to protect Canadian families and businesses during this global storm," said Prime Minister Stephen Harper at the time. "Serving as a Parliamentary Secretary is a big responsibility, and I have tremendous confidence that this is the right

The HRTC will apply to eligible home renovation expenditures for work performed, or goods acquired, after January 27, 2009 and before February 1, 2010 (agreements must have been entered into after January 27, 2009). The temporary nature of the credit will provide an immediate incentive for Canadians to undertake new renovations or accelerate planned projects.

The 15-per-cent credit may be claimed on the portion of eligible expenditures exceeding \$1,000, but not more than \$10,000, meaning that the maximum tax credit that can be received is \$1,350.

About 4.6 million families in Canada are expected to benefit from the credit. Taxpayers can claim the HRTC when filing their 2009 tax return.

This is just one more way that the Conservative government is delivering tax relief during this period of economic turmoil.

# **Passport Update** New Passport Requirements For Travel to the U.S.

The Government of Canada reminds Canadian citizens to prepare now for any travel plans to the United States by applying for an accepted document to enter the United States under the Western Hemisphere Travel Initiative (WHTI). The WHTI is a U.S. law that requires all travellers, including Canadian and American citizens, to present a valid passport or other approved document when entering the United States from within the western hemisphere.



"This Government has worked vigorously with the United States to ensure that legitimate trade and travel across our borders are not disrupted as a result of the new document requirements under the WHTI," said the Honourable Peter Van Loan, Minister of Public Safety. "Our efforts have led to the recognition of enhanced driver's licences and enhanced identification cards as acceptable alternatives to passports."

Effective **June 1, 2009**, Canadian citizens are now required to present a valid passport, a NEXUS or Free and Secure Trade (FAST) card, or an enhanced driver's licence/enhanced identification card when seeking to enter the United States at its land or water crossings. Canadian citizens 15 years of age or under will only require proof of citizenship, such as a birth certificate or a Canadian citizenship card. Canadian citizens 18 years of age or under who are travelling with a school or other organized group, under adult supervision with parental guardian consent, may also present proof of Canadian citizenship alone.

The U.S. document requirements for air travel took effect in January 2007, and require Canadian citizens flying to, through or from the United States to present a valid passport or a valid NEXUS card when used at a NEXUS kiosk at participating Canadian airports or at any U.S. airport when returning to Canada.

# **Track the Progress of** *Canada's Economic Action Plan* Website Helps Hold Governments and Parliamentarians Accountable

The Honourable Jim Flaherty, Minister of Finance has unveiled <u>ActionPlan.gc.ca</u>, a comprehensive new Government of Canada website that will allow Canadians to hold governments and public officials accountable for action on the economy.

"Canadians want governments and public officials at all levels to work together to stimulate the economy," Minister Flaherty said. "They want to see us taking action on the economy in an accountable and transparent manner."

<u>ActionPlan.gc.ca</u> includes details of *Canada's Economic Action Plan*, with links to specifics of initiatives and projects as they are announced. It also explains the roots of the global financial crisis and Canada's relative performance. The website will help Canadians to assess how well parliamentarians, provincial and territorial governments, businesses and others are contributing to positive action on the economy.

One of the most important functions of Mike's constituency office is to help families in Edmonton - Mill Woods - Beaumont navigate the immigration system.

In one such case, Mike's office was made aware of a heart-wrenching situation facing the Largao family, who came to Canada as refugees from Sierra Leone. Misunderstanding our immigration system, the family left their youngest son, Quenty, in Sierra Leone with his aunt, believing they would be able to bring him to Canada shortly thereafter.

When Mike's office first contacted the Largaos after hearing about their plight, their three-year effort to bring their son to Canada had garnered few results. With the help of Mike and his staff, immigration officials, and others, Quenty Largao was reunited with his family in February.


