World Autism Awareness Day Mike's Statement in the House of Commons April 1, 2010

Ottawa

"Mr. Speaker, tomorrow is the third World Autism Awareness Day. Twelve years ago today, my son Jaden was diagnosed with autism. For the last two years on this day, I have shared Jaden's story, but this time I want to focus on his 10-year-old sister, Jenae.

Strengthening the Justice System Government Introduces Amendments to Strengthen Young Offenders Legislation

Ottawa

On Tuesday, March 16, 2010, Rob Nicholson, Canada's Minister of Justice was joined by Minister Christian Paradis and Senator Pierre-Hugues Boisvenu to announce legislative amendments that would strengthen the way the young offenders system deals with violent and repeat young offenders.

"These amendments are entitled Sébastien's Law, in memory of Sébastien Lacasse, and to honour the dedication of his parents, Line and Luc," said Minister Paradis. "The Lacasse family and other courageous families have worked tirelessly as advocates for the rights of victims, to make a difference in the lives of others. In bringing forward these amendments we are acknowledging all Canadian families who have lost loved ones in crimes involving youth violence."

The proposed amendments to the young offenders legislation would:

- make the protection of Canadian communities a primary goal;
- simplify the rules to keep violent and repeat young offenders off the streets while awaiting trial, when necessary to protect society;
- require the Crown to consider seeking adult sentences for youth convicted of the most serious crimes – murder, attempted murder, manslaughter and aggravated assault;

As with many siblings of people with autism, our family's attention often seems to be on someone else, and yet Jenae never complains. She sees the good in her brother, often pointing out, for example, that Jaden never fights with her like her friends' brothers do. When she was five, she described their relationship this way: 'I'm Jaden's little sister, but sometimes I'm like his big sister.'

She is Jaden's guardian, his helper, his teacher and his friend. Jenae's name is Hebrew for 'God has replied' and there are countless others all across this country just like her: people like Josh Bortolotti, Jeanette Holden and the member for Sydney-Victoria (Liberal MP Mark Eyking).

They are answers to prayers both spoken and unspoken, and we thank God for them today on behalf of those who may not be able to say it themselves."

Remembering Vimy Ridge

On Friday, April 9, 2010, Prime Minister Stephen Harper attended a special commemorative ceremony at the National War Memorial and the Tomb of the Unknown Soldier honouring the Canadian men and women who served in the First World War. The ceremony, held on Vimy Ridge Day, also marked the recent passing of John "Jack" Babcock, Canada's last known First World War Veteran.

"Today, we pay homage to the generation whose fearlessness in battle and selflessness in intention defined our young nation in the eyes of the world," said the Prime Minister. "They risked their lives so the people of Europe could live with the same peace and freedom that had taken such deep root in Canada." Between 1914 and 1918, more than 650,000 Canadians and Newfoundlanders served in the First World War. Of these, more than 170,000 were injured and more than 68,000 lost their lives. The extraordinary achievements of Canadian troops and Canada's contribution to the First World War resulted in Canada's emergence as a sovereign nation.

"With the passing of John 'Jack' Babcock earlier this year, Canada sadly lost its last living link to that generation," added the Prime Minister. "While those Canadians who fought in that epic struggle may now have passed from the face of the earth, their legacy lives on all around us."


- enable the courts to impose more appropriate sentences on other violent and repeat offenders, as necessary in individual cases to use existing sanctions in a way that would discourage an individual from offending again; to use a pattern of escalating criminal activity to seek a custodial sentence when necessary; to impose a custodial sentence for reckless behaviour that puts the lives and safety of others at risk; and
- require the courts to publish the name of a violent young offender when necessary for the protection of society.

Regarding the requirement to consider adult sentences for youth convicted of the most serious crimes, the provinces and territories will still have the discretion to set the age at which this requirement would apply.

The amendments would also ensure that offenders under the age of 18 who are sentenced to custody will be placed in youth facilities only, even if they receive an adult sentence.

"Our government is proud to stand up for the rights of victims and law-abiding citizens," said Senator Boisvenu. "Today we have taken an important step forward in strengthening our youth criminal justice system. We are helping ensure that justice will be served, and that Canadians will be protected from violent and repeat offenders."

Canadians Give Generously to the People of Haiti

On January 12, 2010, a catastrophic earthquake measuring 7.0 on the Richter scale struck Haiti, close to Port-au-Prince. That quake has caused widespread devastation and loss of life. The Government of Canada continues to extend its sincerest condolences to those affected by this terrible tragedy.

Since the first moments after the earthquake, Canadian officials in Ottawa and in Port-au-Prince have been actively working to support Canadians and Haitians in distress. Canadian officials have worked tirelessly to evacuate hundreds of Canadians to safety, and the Government of Canada has been working with the Government of Haiti, the United Nations, other donors and trusted humanitarian partners with a presence in the region to ensure that urgent and effective relief reaches those most in need.

Individual Canadians have also stepped up in unprecedented numbers, donating \$220 million to the Haiti Earthquake Relief Fund, an amount that will be matched dollar-for-dollar by the Canadian government.

The Haiti Earthquake Relief Fund is providing effective, accountable and timely financial support to trusted Canadian and international humanitarian and development partner organizations working in the affected area.

The mission of Homeless Connect is to "provide services that help open doors out of homelessness, build lasting partnerships, raise public awareness of homelessness in the community, and provide a vehicle for community involvement in addressing the issue of homelessness."

Services include mental health assessments, library services, foot care, haircuts, immunizations, birth control, pre-natal support, laundry, housing information, employment and training services and much more.

Government of Canada Makes Significant Investment in Jackie Parker Recreation Area

Edmonton

The federal government is making a substantial commitment to the people of Mill Woods through it's investment in the Jackie Parker Recreation Area. Funding for this project is being provided under the Recreational Infrastructure Canada (RInC) program, a major job-creating component of *Canada's Economic Action Plan*.

"Our Government's investment in the Recreational Infrastructure Canada program is creating jobs for Canadians, while encouraging greater participation in physical activities and the use of recreational facilities," said Mike at the time. "Investing in the Jackie Parker Recreation Area will help the government stimulate the economy, while creating a place where Edmonton families will come together to stay active and have fun for years to come."

The \$733,387 of RInC funding will go toward the construction of a spray park, a boulder park and a playground.


