## Mike Appointed to the Queen's Privy Council for Canada

#### Ottawa

On September 13th, Mike was sworn into the Queen's Privy Council for Canada, along with Ron Cannan, which enables them to serve on the Priorities and Planning Sub-Committee on Government Administration.

This Sub-Committee has been mandated to consider proposals on whole-ofgovernment opportunities for improved efficiency and effectiveness. The Sub -Committee will work to determine what additional, common sense improvements can be made in government.

The Queen's Privy Council is the group of cabinet ministers, former cabinet ministers and other prominent Canadians appointed to advise the Queen on issues of importance to the country. This includes both issues of state and constitutional affairs.

The Governor General appoints each privy councillor on the advice of the

## Mike and Son, Jaden, Speak at *World Focus on Autism* Event in New York City

On Thursday, September 27th, Mike and his 16-year-old son, Jaden, were in New York to speak at the Fifth Annual *World Focus on Autism*, an event for spouses of world leaders and members of the disability community, co-hosted by the wife of the UN Secretary-General and Autism Speaks.

Bob and Suzanne Wright, co-founders of Autism Speaks, urged attendees to support a new U.N. resolution on autism spectrum disorders (ASD) and developmental disabilities that was introduced by Her Excellency Sheikh Hasina, the honourable Prime Minister of Bangladesh, during the 67th United Nations General Assembly session. The resolution calls for greater participation of the U.N. in recognizing autism as a public health crisis, and encourages member states to tackle developmental disorders at the local, national and international levels.

"The resolution will help individuals and their families with developmental

disorders become a part of our life in terms of economic contribution, social participation and political significance," Sheikh Hasina said. "We urge you to support, and raise awareness around the new UN resolution. With your support, we believe the resolution will be adopted and this small step for a small fraction of mankind will lead to a big leap towards better humanity."

This year's *World Focus on Autism* brought together more than 15 first spouses and two heads of state in an unprecedented show of support to raise awareness of autism around the world and encourage collaboration among

### Mike Appointed to Queen's Privy Council

- Former chief justices
- Former speakers of the House of Commons
- Former speakers of the Senate
- Former Governors General •
- Distinguished individuals (as a mark of honour) •

The Queen's Privy Council for Canada was first established by the British North America Act, 1867 (later renamed the Constitution Act, 1867). It has been adding members ever since.

Privy Councillors receive a document called a commission from the Governor General, summoning them to the Privy Council; swear two oaths: the Oath of Allegiance to the Queen, and the Oath of the Members of the Privy Council, and sign the Oath Book; carry the title "Honourable" for life and use the initials "P.C." after their names; are given a position of precedence on the Table of Precedence; and are honoured by half-masting of the flag on the Peace Tower upon their deaths. There are currently about 360 members of the Queen's Privy Council for Canada.

## **Canada: An Economic Model, Leading the Developed World in Jobs and Growth**

#### Ottawa

In recent weeks, the heads of two of the world's leading economic organizations - the International Monetary Fund (IMF) and the Organisation for Economic Co-operation and Development (OECD) - have singled out Canada's economic and fiscal leadership for praise, and have pointed to Canada as a model for the world to follow.

The IMF and OECD each predict our economic growth will be among the strongest in the industrialized world over the next two years. IMF Managing Director Christine Lagarde, formerly France's Finance Minister, notes, "Canada can teach the rest of the world about how to build a stronger, safer financial system ... If I look at Canada and the anomaly that it constitutes compared to other countries—because it's growing pretty well, because its banking system is solid and growing, because its inflation is under control, because its fiscal deficit is also pretty much under control and its level of indebtedness is reasonable-you know, it's not bad a scorecard."

"(Canada is) well prepared. You have been better prepared and therefore you've weathered the storm a lot better. You are well prepared now. Your fiscal policy, your monetary policy, your financial system (is) in better shape. And therefore, you are doing better in ... the world economy."

Here are a few details from the scorecard to which Ms. Lagarde refers:

Since July 2009, Canada has seen over 820,000 net new jobs created. This is the best job growth record in the G-7, a group of countries that includes Germany and the United Kingdom.

OECD Secretary General Angel Gurria was similarly congratulatory, saying,

- Forbes magazine ranked Canada the best country in the world to do business.
- Canada still maintains the lowest debt-to-GDP ratio in the G-7.
- All three of the major credit rating agencies, Moody's, Fitch, and Standard & Poor's, have reaffirmed Canada's top credit rating.
- The World Economic Forum says our banks are the soundest in the world.
